ENTRY METHOD: FIRST RECEIVED

ENTRIES: Early entry date period for terriers only is August 10-17, 2020. After that date, the trials are open to all breeds and mixed breeds. All entries received before these dates will be returned. Overnight or certified mail must be sent with the "No Signature Required" waiver signed.

ENTRIES CLOSE: September 21, 2020, 6:00 p.m. after which time entries cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows.

Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

Paper entries received within 24 hrs. of the opening date & time must: 1) include postage or be metered; 2) be delivered by a multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS & DHL. If above conditions are not met, the entries are not valid and must be returned to the sender.

The Trial Secretary is not responsible for entries not received or cancelled by specified dates. Please refer to the official AKC rule books to make sure you understand the rules set forth for entering AKC

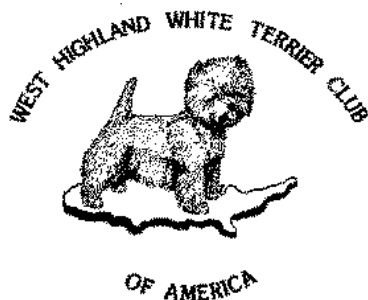

ROUTES TO THE TRIAL

From I-83:

I-83 to Exit 32 (Newbery exit). **Northbound** – At the light at the bottom of the ramp, turn left onto Rt. 382 North to Lewisberry. Go approximately 3 miles to the flashing traffic light and turn left onto Rt. 177 South toward Rossville. Go approximately 4 miles and turn right on Mt Airy Rd (across from Gifford Pinchot State Park). Continue approximately 1.7 miles to the site on the left. **Southbound** - At the light at the bottom of the ramp turn right onto Rt 382 North to Lewisberry. Follow directions above.

From US-15:

Take Bowmansdale exit Rt. 114 towards Roundtop Mountain Resort. At traffic light at the bottom of the hill, proceed straight on South Market St. DO NOT FOLLOW 114. Continue straight about 2.3 miles on South Market St which will become North York Rd. Turn left on East Mt. Airy Rd (at Mt. Pleasant Church of God) and go approximately 4.5 miles. You will pass Roundtop Mountain Resort on the right. Continue to a “T” intersection and turn right on Pinetown Rd. Take the first left onto Mt Airy Rd. Site is immediately on the right.

Use 730 Mt Airy Rd, Lewisberry, PA. Make sure you do not use East Mt Airy Rd.

EXHIBITOR INFORMATION

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Club, Bella Vista and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The club and/or BVTC reserve the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the club, BVTC or any official thereof.

All dogs must be on leash at all times when on trial grounds except when competing on the course.

All regulations governing the use of this facility, and all regulations and decisions of the trial committee at this trial will be strictly enforced, including and not limited to the recorded information of this premium list. Puppies under 4 months of age are prohibited at AKC Rally Trials.

The club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

All refund requests received prior to the close of entries will be charged a \$5.00 per day processing fee.

A refund of entries minus \$20 per dog per day for injured dogs/bitches in season will be granted when a veterinarian's letter is presented as proof to the Trial Secretary no later than one half hour prior to the start of the first class of the day of the trial. Letter must be on official Vet Letter Head. No copies, facsimiles or emails.

CRATING and SEATING

Information on these topics will be sent out with the final confirmation. Crating will be indoors in a climate controlled room. Current COVID 19 rules regarding masks and social distancing will be enforced.

RINGSIDE

Dogs may arrive any time prior to judging. Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Exhibitors may bring their own chairs.

PARKING

Exhibitors are governed by any rules or regulations of civil authorities and building and parking regulations. Vehicles parked contrary to regulations will be subject to towing at owner's expense.

PLEASE NOTE: A limited number of handicap spaces are available. They will be available on a first-come basis. A valid handicap plate/placard must be on each vehicle using these spaces.

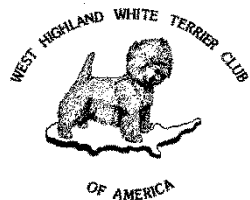
RV/OVERSIZED VEHICLE PARKING: RV's and Oversized Vehicles are not allowed to park in the regular parking spaces. Oversized Vehicles are defined as those vehicles that do not easily fit in a parking space either by width or length. No trailers.

Club officials may require that vehicles or equipment be rearranged to accommodate additional vehicles. Area around vehicles MUST be kept clean at all times. INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
